ORDINANCE NO. 15

AN ORDINANCE ACCEPTING AND ORDAINING AS PUBLIC STREETS CERTAIN OPEN STREETS IN THE BOROUGH OF INDIAN LAKE, SOMERSET COUNTY, PENNSYLVANIA

WHEREAS, the Borough of Indian Lake was created on April 1, 1966, but the streets within said Borough have remained privately owned opened streets; and

WHEREAS, it is desirable in the best interests of the public that certain of said streets become public streets and the owners thereof have offered and are willing to deed certain of said streets to the Borough of Indian Lake without consideration or claim of damages or compensation therefor;

NOW, THEREFORE, THE BOROUGH OF INDIAN LAKE HEREBY ORDAINS AS FOLLOWS:

Section 1: The following named streets, which are hereby designated as so named as hereinafter set forth, are hereby accepted and ordained as public streets in the Borough of Indian Lake, Somerset County, Pennsylvania:

RIGHTS OF WAY 50 FEET WIDE:

South Shore Trail from the western edge of Ottawa Park a distance of 5,131.10 feet to the northeastern edge of Delaware Park. 1,038.8 = 6,161,90

Cherry Lane from its intersection with South Shore Trail a distance of 779.55 feet to T-567.

Wenatchee Path from its intersection with South Shore Trail a distance of 1,028.25 feet in an easterly direction.

Peninsula Drive from its intersection with a private road owned by Wenatchee, Inc., a distance of 25,673.39 feet. Same

South Peninsula Road from its intersection with Peninsula Drive a distance of 3,170.70 feet in a southeasterly direction.

Clear Run Road from its intersection with Peninsula Drive a distance of 3,756.33 feet to its intersection with Fairway East Road.

North Peninsula Road from its intersection with Peninsula Drive a distance of 1,303.40 feet to its intersection with Peninsula Drive.

Fairway East Road from its intersection with Peninsula Drive a distance of 4,574.82 feet in an easterly then a northerly direction.

Lincoln Entrance Road from its intersection with Fairway East Road a distance of 2,574.23 feet to the northern edge of the East West Runway of Airpark.

Airpark Drive from its intersection with Peninsula Drive a distance of 915.00 feet in a northerly direction to the intersection of Airpark East Road.

Airpark East Road from its intersection with Airpark Drive a distance of 3,064.28 feet.

Airpark West Road from its intersection with Airpark Drive a distance of 4,205.56 feet to its intersection with North South Runway.

Fairway West Road from its intersection with Peninsula Drive a distance of 727.80 feet to intersection with Peninsula Drive.

Point Circle Drive from its intersection with Peninsula Drive a distance of 828.80 feet.

Fairway North Road from its intersection with Peninsula Drive a distance of 1,597.70 feet.

Shoshone Path from its intersection with Peninsula Drive a distance of 928.00 feet to its intersection with North Shore Trail.

Shoshone Circle Drive from its intersection with Shoshone Path a distance of 2,695.11 feet.

Poorbaugh Path from its intersection with Shoshone Circle Drive a distance of 1,425.00 feet to LR 55069.

North Shore Trail from its intersection with Shoshone Path a distance of 5,035.10 feet to the western edge of Niagara Park.

Mohawk Path from its intersection with North Shore Trail a distance of 2,864.33 feet.

Sioux Path from its intersection with North Shore Trail a distance of 3,454.00 feet to its intersection with North Shore Trail.

West Shore Trail from the western edge of Osage Park a distance of 5,955.70 feet to its intersection with T-569.

Osage Lane from its intersection with West Shore Trail a distance of 587.80 feet.

Potomac Lane from its intersection with West Shore Trail a distance of 1,200.00 feet.

The total distance of the rights of way hereinabove described 50 feet in width is 83,475.95 feet or 15.80 miles, with a total area thereof being 95.81 acres.

The total distance of the rights of way hereinabove described 20 feet in width is 15,644.50 feet or 2.96 miles, with a total area thereof being 7.180 acres.

Section 2: A plan or map of the aforesaid described streets in the Borough of Indian Lake setting forth the description in courses and distances and the location of said streets within the Borough of Indian Lake is attached to this Ordinance and made a part hereof.

Section 3: All ordinances and parts of ordinances inconsistent herewith are hereby repealed.
