

INDIAN LAKE BOROUGH
ORDINANCE NO. 152

AMENDMENT TO ORDINANCE NO. 116 PROVIDING FOR A CHANGE IN
THE DEFINITION OF THE TERM "PONTOON BOAT" AND A CHANGE TO
THE CLASSIFICATION OF A SAIL BOAT FROM A POWERED BOAT TO A
NON-POWERED BOAT

WHEREAS, on January 16, 2000, Ordinance No. 116 titled, "AN ORDINANCE OF THE BOROUGH OF INDIAN LAKE, SOMERSET COUNTY, PENNSYLVANIA, REGULATING THE USE AND ENJOYMENT OF INDIAN LAKE FOR RECREATIONAL AND OTHER PURPOSES; CONSOLIDATING AND RESTATING ALL PRIOR BOATING ORDINANCES AND AMENDMENTS THERETO," was enacted by Borough Council and executed by the Mayor at a duly advertised meeting; and,

WHEREAS, after careful consideration, Indian Lake Borough Council desires to amend the Ordinance by modifying the definition of the term "pontoon boat" and changing the classification of sail boats from a powered boat to a non-powered boat, as well as delete sections that are inconsistent with the intent and purpose of this Ordinance.

NOW, THEREFORE, the Borough of Indian Lake does hereby ordain and enact as follows:

Article I., Section 101 A. (Type) of the Ordinance, is hereby amended by deleting the following language:

For purposes of this Section, a "pontoon boat" shall be a boat floating on two tubular pontoons. . . .

In lieu thereof, the following language shall be inserted:

For purposes of this Section, a "pontoon boat" shall be defined as a boat floating on one or more tubular pontoons. A sail boat shall not exceed twenty-two (22' 00") feet in length, whether or not it has a single-hull or pontoon configuration, and shall for the purpose of this Ordinance be considered a non-powered boat.

Article I., Section 102 B. (Secondary Licenses) of the Ordinance is hereby amended to delete the words "or sail".

Article I, Section 102 B. (Secondary Licenses) of the Ordinance shall further be amended to read as follows:

In addition to the above licenses, a property owner may make application for boat licenses for manually powered or sail powered vessels, such as rowboats, canoes and sail boats.

Article I, Section 102 C. (General Licenses) of the Ordinance is hereby amended to delete the words "or sail".

Article I, Section 102 E. (Commercial Rental Licenses) of the Ordinance is hereby amended to add the term "sail boat" under the Nonpowered Watercraft section of E. 1. b. and E. 2. b.

Article I, Section 102 K. (Proof of Liability) of the Ordinance is hereby amended to delete the words "or sail".

All other terms and conditions of the Ordinance enacted and ordained January 12, 2000, and amendments thereafter, are reaffirmed and incorporated herein by reference.
