## ORDINANCE NO. 75

AN ORDINANCE AMENDING ORDINANCE NO. 60 OF THE BOROUGH OF INDIAN LAKE REGULATING THE INSTALLATION OF SEWAGE DISPOSAL.

WHEREAS, the Borough of Indian Lake has embarked upon a comprehensive modification to its sewage disposal rate structure; and,

WHEREAS, the Borough of Indian Lake, in the furtherance of that comprehensive structure, has determined it to be necessary to classify and restructure the examination, evaluation and permitting of plot plans and sewage disposal systems; and,

WHEREAS, the Borough of Indian Lake, in furtherance of that comprehensive structure, desires to provide for a separate rate program for separate and distinct services to be performed.

BE IT ENACTED AND ORDAINED and it is hereby enacted and ordained that the Ordinance No. 60 of the Borough of Indian Lake is amended to read as follows:

SECTION 1: The rate structure for sewage disposal and related matters in the Borough of Indian Lake are attached hereto and made a part hereof as Schedule "A". Said rate structure may be amended and modified by the Borough, at various times, when deemed appropriate by a Resolution properly adopted thereby. All fees shall be retained by the Borough of Indian Lake whenever the specific service is performed and whether or not the permit requested, if applicable, is granted or denied.
