ORDINANCE NO. 76

AN ORDINANCE AMENDING SECTION 1 OF ORDINANCE NO. 15 AND ORDINANCE NO. 26 OF THE BOROUGH OF INDIAN LAKE KNOWN AS THE "ORDINANCE ACCEPTING AND ORDAINING AS PUBLIC STREETS CERTAIN OPEN STREETS IN THE BOROUGH OF INDIAN LAKE, SOMERSET COUNTY, PENNSYLVANIA."

WHEREAS, on August 24, 1970, Allegheny Mountain Lakes, Inc., a Pennsylvania corporation, deeded to the Borough of Indian Lake, various open roads; and,

WHEREAS, on August 24, 1970, Indian Lake adopted Ordinance No. 15 accepting and ordaining various open roads as public streets of Indian Lake Borough; and,

WHEREAS, on September 12, 1975, Indian Lake Borough amended Ordinance No. 15 by enacting Ordinance No. 26, accepting and ordaining several other open roads previously deeded as public streets of Indian Lake Borough; and,

WHEREAS, now, the Indian Lake Borough desires to accept and ordain several other open roads previously conveyed but not accepted and ordained; and,

WHEREAS, the road to be accepted and ordained connects with at least one other previously opened street or State highway; and,

WHEREAS, the Borough Council of Indian Lake has deemed it to be in the best interests of the Borough of Indian Lake to accept said road as a part of the public road system of the Borough.

NOW, THEREFORE, BE IT ORDAINED AND ENACTED by the Borough of Indian Lake, Somerset County, Pennsylvania, and IT IS HEREBY ORDAINED AND ENACTED by the authority of the same as follows:

ARTICLE ONE. Section 1 of Ordinances No. 15 and No. 26 are amended by adding the following: The following named streets, which are hereby designated as so named as hereinafter set forth, are hereby accepted and ordained as public streets in the Borough of Indian Lake, Somerset County, Pennsylvania:

RIGHTS-OF-WAY 20 FEET WIDE:

Chactow Lane 602.9 feet Mohawk Lane 500 feet

ARTICLE TWO. All Ordinances and parts of Ordinances inconsistent herewith are hereby repealed.

ARTICLE THREE. This Ordinance shall become effective thirty (30) days following its enactment.

ARTICLE FOUR. The Borough Secretary is hereby directed to give notice of the enactment of the Ordinance as is required by law.
