A RESOLUTION OF THE COUNCIL OF THE BOROUGH OF INDIAN LAKE, SOMERSET COUNTY, PENNSYLVANIA RENAMING A CERTAIN PUBLIC STREET KNOWN AS "INDIAN LAKE DRIVE" AND, ULTIMATELY, CONTINUING AS "PENINSULA DRIVE," SIMPLY AS "PENINSULA DRIVE"

WHEREAS, the Pennsylvania Borough Code, 8 Pa.C.S.A. §§ 101 et seq., generally empowers borough councils to regulate streets located within their respective borough boundaries;

WHEREAS, currently, within the Borough of Indian Lake, Somerset County, Pennsylvania (hereinafter the "Borough"), there exists a certain public street wholly contained within the Borough's boundaries more particularly identified as the "Entrance Road to S.R. 0030" as shown on an Indian Lake Borough Boundary survey prepared by Thomas Edward Kimmel, Registered Professional Land Surveyor, of CME Engineering LP dated December 13, 2016 and recorded in the Office of the Recorder of Deeds of Somerset County, Pennsylvania on March 10, 2017 at Plat Book Volume 38, Page 100; said public street being more commonly known as "Indian Lake Drive";

WHEREAS, the aforementioned "Indian Lake Drive" generally begins at a point intersecting State Route 0030 and, thereafter, runs in a general southerly direction; ultimately, continuing as "Peninsula Drive";

WHEREAS, Borough Council has deemed it to be in the best interests of the Borough to rename the entire aforementioned public street hereinabove described simply as "Peninsula Drive" and to cease all use of the name "Indian Lake Drive" to designate any portion thereof; and

WHEREAS, Borough Council hereby desires to memorialize said action in the form of the Resolution herein.

NOW, THEREFORE, BE IT RESOLVED, and incorporating the foregoing recital clauses by reference herein, that the Council of the Borough of Indian Lake, Somerset County, Pennsylvania, hereby adopts this Resolution to rename the entirety of all of that public street currently known as "Indian Lake Drive" and, ultimately, continuing as "Peninsula Drive," simply as "Peninsula Drive."

BE IT FURTHER RESOLVED, that Borough Council or its designee is hereby authorized to contact any and all appropriate authorities, including, without limitation, the Commonwealth of Pennsylvania, Department of Transportation, and the EMA/911 Department of the County of Somerset, Pennsylvania, to notify said parties of the actions taken hereby.
